Job Summary			

Assist with the day-to-day activities of the assigned NYLT Session. Make sure to pack up food according to the food schedule. Works with the Youth QMs to mentor them in their roles as QM. Helps to maintain and inventory the equipment for NYLT. Works with the CD to make sure that all food and equipment are ready for each day.

Job Description

ROLE AND RESPONSIBILITIES

- Maintains an inventory of supplies and where they are being distributed.
- Maintain the cleanliness and organization of the quartermaster area and the kitchen.
- Check refrigerator and freezer temperatures and record two-three times daily.
- If temperatures are not in the correct zones for maintaining food safety, let Course Director/Council Coordiator/or Camp Director know.
- Participate in staff training sessions.
- Assist with the inventory and distribution of supplies, materials and food.
- Assist with ensuring all paperwork is completed for participants and staff.
- Ensures all Youth Protection and adult supervision requirements are met.
- Manage trash at NYLT daily. Taking a trash run to the main trash dump on MSR, and properly disposing of trash.
- Help recruit youth participants.
- Model the core learning and leadership messages of the NYLT Syllabus.
- Model core learning and leadership messages of the NYLT syllabus.
- Be familiar with and direct the camp emergency procedures as directed by the MSR Ranch Director as needed.
- Coordinate and inform the MSR Ranch Director of all issues while on site. Assist with investigations and response. Report issues with participants and staff immediately.
- Assist in cleaning camp areas and buildings. This includes removing trash, cleaning restrooms and showers, and making sure the QM areas (including storage at shelters, and kitchen at HQ) are ready for the next program.
- Other duties as assigned.
