<p><b>ROLE AND RESPONSIBILITIES</b></p> <ul style="list-style-type: none"> <li>• Be a mentor to the Senior Patrol Leaders (SPL).</li> <li>• Attend all Staff Development Trainings (including All Hands, Staff Developments, and other trainings as required by Council.)</li> <li>• Model the core learning and leadership messages of the NYLT Syllabus.</li> <li>• Coordinate joint sessions, meetings, and activities throughout the course.</li> <li>• Help serve as the course administrator and provide support to all staff before and during the course.</li> <li>• Help Recruit youth staff.</li> <li>• Help Recruit youth participants.</li> <li>• Be well-versed in all core content sessions and activities in order to act as a resource.</li> <li>• Be familiar with camp emergency procedures.</li> <li>• Report all issues with participants or staff to the NYLT Course Director and MSR Ranch Director as necessary.</li> <li>• Work with the QM team to make sure that program runs smoothly during camp.</li> <li>• Assist in cleaning camp areas and buildings. This includes removing trash, cleaning restrooms and showers, and making sure all areas of camp are ready for the next program.</li> <li>• Other duties as assigned.</li> </ul> <p><b>CERTIFICATIONS &amp; REQUIRED TRAINING</b></p> <ul style="list-style-type: none"> <li>• CPR, AED, First Aid Certification (Not provided by the Council)</li> <li>• Youth Protection (Online Prior to Camp)</li> <li>• Other training as required by Council and NYLT Management</li> </ul> <p><b>REQUIRED FOR THE JOB</b></p> <ul style="list-style-type: none"> <li>• Must be 18-20 – an adult participant in the BSA Programs</li> <li>• Must have served in the SPL or ASPL role and have the recommendation of the Scoutmaster or Course Director of their SPL/ASPL course.</li> <li>• Must be able to read, speak, and write the English language</li> <li>• Must be able to work outdoors at an elevation of 7,000+ feet above sea level in varying weather conditions</li> <li>• Must be able to pass a background check from the TRAILS database, CBI and the FBI</li> <li>• Must be a member of the Boy Scouts of America</li> <li>• Should attend a Course Directors Conference.</li> <li>• Must be 16 years of age or older</li> </ul> <p><b>DIRECTLY SUPERVISES</b></p> <ul style="list-style-type: none"> <li>• NYLT Youth Staff</li> </ul>

NYLT Policy on missing Staff Development (includes Staff Developments, All Hands, and other trainings required by council) Dates.

If you need to miss one Staff Development meeting, you need to have a conversation with your Scoutmaster and Senior Patrol Leader.

If you need to miss a second Staff Development meeting, you need to have a conversation with your Scoutmaster, Senior Patrol Leader, and the Course Director.

If you need to miss a third Staff Development meeting, you will need to have a conversation with the Council Coordinator. This conversation will likely end in you being asked to not staff NYLT for the year.
